## CRETE PUBLIC LIBRARY DISTRICT BOARD OF TRUSTEES SPECIAL BOARD MEETING JUNE 5, 2013

- I. Call to order: Meeting called to order by President Tuttle at 7:00 p.m. Those in attendance: President Tuttle, board members: Amati, Boehner, Sizemore & Warren. Also in attendance: Administrator Schulten, Admin. Asst. Bonfiglio. Phyllis Monks & Heather Van Zyl.
- II. Swearing in of new trustees: Ms. Monks & Ms. VanZyl were sworn in.
- III. Renovation update & timelines: The majority of the flooring & paint has been completed. Temporary service desks have been set up until the custom desks are sent. Doors & windows for the meeting room spaces will be sent soon. They also still need trim some electrical & ceiling tiles. The install on the upstairs HVAC unit will start tomorrow. Vans Steel has agreed to cut down the double shelf bases so they can be used on single sided shelves. The first of the furniture is expected to arrive in a couple weeks. The DIRTT walls for the young adult area will be installed next week.
- IV. Change orders (action): R. Smith Construction took on the task of the tile flooring as well as removal of several desks; they will also build a small knee wall to hide some electric. Motion to approve all bills for payment by Sizemore, second by Boehner. Motion passed on voice vote. Ayes: Amati, Boehner, Monks, Sizemore, Van Zyl & Warren. Nays: None.
